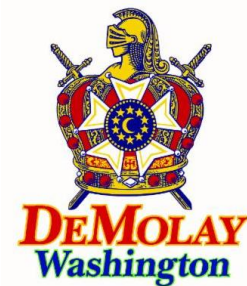

Greetings Member and Advisors,

Thank you to the over 50 people who signed in and watched our first ever online Candidates for State Office Caucus on Saturday! This was exciting and nerve wracking at the same time. Thank you to the Candidates for your energy and efforts in making this all come together.

This morning, every Voting Delegate should have received via email their unique individual Ballot at **12:01am**. This process is being handled through an online election service. Remember voting will only remain open until **11:59pm on Monday** (that's tomorrow). Voting Delegates will not be able to vote outside this window. Per our By-Laws an election is had if a candidate obtains 50% + 1 vote of the total votes cast.

Reminder - On **Tuesday evening**, State Master Councilor Colton Jenkins will announce the results of the election and Executive Officer Dad Brunson will approve and appoint the Elected State Corps until the Formal Installation of Officers can be held at Conclave in Wenatchee on Saturday, August 1st.

## **The Office Convention: Re-run. July 31 ~ August 2, 2020**

Hello everyone. We have been finalizing contracts to "Re-run" the Office Convention 2020. Thank you everyone for your patience while we have been working through this Covid process and we are very excited to share the details with you now. Oh God, my mind is going a mile an hour.

As you have heard through the last two EO Briefings, Convention will be happening from July 31st - August 2nd in Wenatchee. We will be staying at the Coast Hotel and using the attached Wenatchee Convention Center. This year we had the largest registration for a Convention that we have had in years and we are hoping that those same people will be able to make the new date and location work. We understand that this will not be possible for everyone, however, so we are implementing the following process to reconfirm registration for those that can attend and issuing refunds for those who cannot.

In the next week, Convention Registrar, Dad Brandon McGee will begin contacting each Chapter or Registration Group. They will be asked to confirm current registrants by May 31st. Any new registrations, will need to be received by June 30th. Refunds for the excess or total refund will begin July 1st. Refunds will be issued back to the Chapter or Group for further processing and refunding to the registrants.

New this year, we implemented a Super Early Bird and Early Bird Discount. These discounts will still be honored and applied to the Convention Re-run.

The Corps will begin advertising all of the fun and activities that will be happening at Convention, but you can expect the same high level event that you have come to expect, complete with ritual competitions, late night fun and games, and lots of brotherhood.

The base cost breakdown for The Office Convention Re-run is as follows:

Full-time Registration - 4 to a Room - \$210 per Person  
Full-time Registration - 3 to a Room - \$245 per Person  
Full-time Registration - 2 to a Room - \$295 per Person  
Full-time Registration - 1 to a Room - \$445 per Person

Super Early Bird Discount - (deduct \$30)  
Early Bird Discount - (deduct \$15)

Again, thank you for your patience through this process and we really hope that you can join us for the FUN in Wenatchee.
